1 Subject acceptance and channel

This licence is between the owner identified above (Licensor) and the individual identified in the purchase (Licensee), for use of the purchased edition of Spectrochord on compatible Macs. The software is licensed without transfer of its intellectual property. Rights in the application, logo, documentation and resources remain with their respective holders.

The licence must be available before purchase. The order and receipt identify the edition, price and purchased scope. For direct sales through the PHI PICKS store, Lemon Squeezy acts as reseller and Merchant of Record, handling payment and transaction documents. The Licensor remains responsible for the application and its own support obligations. If you disagree, do not install the copy and exercise applicable rights through the seller.

Mandatory law and purchasing channel rules prevail. Specific written terms supplement this licence without reducing mandatory rights. Buying through one channel does not automatically provide a copy, refund or update through another.

2 Individual scope

An individual licence is assigned to one person. That person may install and use the purchased edition on Macs they own or control for their own work. This licence sets no numerical limit on personal Macs but grants no seats to other users. Using two personal computers does not create a second transferable licence.

Lessons and demonstrations, including paid work, are permitted on the holder's Mac. Installation on students' or colleagues' Macs or in a laboratory requires separate licences or an appropriate institutional agreement. Do not share purchasing credentials or private file access links.

3 Musical use and outputs

The licence permits study, composition, teaching, demonstrations and use of musical outputs in personal or professional work within the purchased scope. The Licensee may incorporate rendered audio, notation and exported images in compositions, recordings, presentations and teaching materials, including commercial work, without additional royalties to the Licensor.

This permission does not allow extracting or redistributing isolated samples, building competing sound libraries from those resources, reselling the application or presenting its branding as one's own. Third-party rights in user-supplied content still apply. Exclusivity or copyright protection is not promised for every generated phrase: other users may obtain similar results.

References and logos in an export do not imply sponsorship. The product may be shown accurately, but using its branding as the identity of another product requires permission. Third-party notices and component licences, including open-source licences, retain their own scope.

4 Copies restrictions and statutory exceptions

Backup copies necessary for lawful use are permitted. The application, installers or credentials must not be made available to people outside the purchased scope, rented, sublicensed or offered as a publicly accessible software service without agreement. Ownership notices must not be removed, and lawfully applicable protection mechanisms must not be circumvented.

These restrictions do not remove non-waivable rights to make backups, study, observe, test, achieve interoperability, correct errors or transfer copies where recognised by law. Reverse engineering is not prohibited where and to the extent permitted by law, and these terms do not narrow an open-source licence.

5 Term updates and support

A direct purchase is a single payment, with no subscription or automatic renewal. The right to use the purchased version has no fixed expiry, subject to valid termination for breach as set out in this licence.

Feature updates, new major versions, services and support periods are those offered at purchase. Free access to all future versions is not promised; this does not remove legally required corrections and updates for conformity and security. The program targets the macOS versions and architectures specified for the distributed edition, without a promise of compatibility with all future systems.

Technical support: hello@spectrochord.com. No guaranteed response time, training or continuous availability is promised unless agreed or legally required. Version 1.0.6 requires no in-app account or remote activation and has no proprietary automatic updater. Future changes must be disclosed before affecting contracted use.

6 Data and liability

Study data are local. A .spectrochord backup enables manual restoration; there is no automatic synchronisation. The Licensee should keep appropriate backups before updates or restoration and manage access to their Mac. This recommendation does not remove the supplier's legal liability for attributable data loss or corruption. Processing of data received by the Licensor is described in the Privacy policy.

The application is a musical exploration tool, with no guarantee of learning, originality or artistic results. The Licensor is liable under applicable law and its commitments. Liability for fraud, gross negligence, personal injury or any non-waivable liability is preserved. No generic monetary liability cap is imposed.

7 Conformity withdrawal and refunds

Applicable rights to conformity, repair, replacement or restoration of conformity, price reduction, termination and refunds remain intact. A digital product does not remove these rights. Payment matters follow the seller identified on the purchase record and applicable mandatory rules.

Where a distance-contract withdrawal right exists, it may be lost when digital supply begins only under the legally required conditions, including prior express consent, acknowledgement of the loss of that right and appropriate confirmation. Installation or general acceptance of this licence does not replace those formalities. This licence does not establish a no-refunds rule.

8 Breach and termination

For a material breach, the Licensor will give notice and allow 30 days to remedy it where remediable before terminating the licence. Immediate action applies only where legally justified, such as preventing continued unlawful distribution. The Licensee may stop using the program at any time, without that alone creating a refund entitlement.

Following valid termination, stop using and remove program copies that are no longer authorised. The Licensee may retain their compositions, exports and own data and continue using musical outputs lawfully created. Intellectual property duties, any agreed confidentiality obligations and accrued liabilities survive.

9 Law disputes and language versions

Portuguese law applies without removing mandatory protections of a consumer's country of residence or rights concerning court jurisdiction. No compulsory arbitration or exclusive forum is imposed on consumers. Contact hello@spectrochord.com to seek a resolution; applicable legal and alternative dispute resolution routes remain available.

The Portuguese, English, Spanish and French versions have the same intended scope. Any discrepancy should be corrected according to the parties' common contractual intent and applicable law, without selecting a translation that reduces mandatory rights. Invalidity of a provision does not affect the remainder where it can stand. Future changes do not retrospectively alter acquired rights without a legal basis or valid agreement.

10 Other distribution channels

This licence covers direct sales through Lemon Squeezy. Developer ID signing and notarisation of the macOS edition do not mean that the application is available on the Mac App Store.

If a Mac App Store edition is released, its listing will identify the applicable licence and Apple terms before purchase. A direct purchase does not automatically grant a copy through that channel. This document is not presented as a custom licence already approved for the Mac App Store.
